# ABOUT ASC

#### VISION

An ASEAN Community that respects the human rights of all people regardless of their sexual orientation, gender identity, gender expression, and sex characteristics (SOGIESC).

#### **MISSION**

ASC is a regional network that dynamically engages diverse actors to collectively advocate for the human rights of lesbian, gay, bisexual, transgender, intersex, queer people, non-binary and gender-diverse persons in Southeast Asia.

#### **GOALS**

ASC works towards the following goals:

- All human rights mechanisms impacting the ASEAN region adopt and implement frameworks and plans of action that promote and protect the rights of LGBTIQ, non-binary, and gender-diverse persons.
- Domestic laws, policies, and programs in Southeast Asian countries include the protection and promotion of the rights of LGBTIQ, nonbinary and gender-diverse persons.
- LGBTIQ, non-binary, and gender-diverse civil society are empowered to engage state and non-state actors to adhere to human rights standards.

# HISTORY OF ASC

ASEAN SOGIE Caucus (ASC) is a network of human rights activists from Southeast Asia that works for the inclusion of sexual orientation, gender identity, gender expression, and sex characteristics (SOGIESC) into the human rights work in ASEAN. Advocating for the human rights of all persons regardless of SOGIESC is at the heart of ASC's mission.

Our roots go back to the courageous action of activists from eight (8) ASEAN countries, namely Cambodia, Indonesia, Malaysia, Myanmar, Philippines, Singapore, Thailand, and Viet Nam. Our founders ensured the visibility and meaningful engagement of LGBTIQ voices in ASEAN civil society spaces, especially the annual ASEAN Civil Society Conference/ ASEAN People's Forum (ACSC/APF). Since 2010, our founders ensured that LGBTIQ issues are addressed in the ASEAN civil society actions and recommendations reflected in outcome documents.

In 2011, ASC was formally established during a meeting of LGBTIQ activists held in Jakarta, Indonesia in preparation for the ACSC/APF of that year. This meeting was organized jointly by Arus Pelangi, Indonesia for Humans, and iSEE. ASC recognizes that its birth and evolution occurred alongside the expanding spaces for regional civil society's engagement with ASEAN.

In 2014, ASC began setting up its Secretariat in Quezon City, Philippines and eventually gained legal registration as a non-stock, non-profit organization the following year. Since then, we have pushed for LGBTIQ human rights through engagements in civil society platforms and human rights mechanisms; supported local LGBTIQ activists through mentorship, technical assistance, and relationship-building; and reimagined activism as a creative process anchored on a vision of South-South solidarity.

In 2021, ASC was granted a Special Consultative Status by the UN Economic and Social Council (ECOSOC).

# SUPPORTING LOCAL ACTIVISM IN THE CONTEXT OF ASEAN

LGBTQIAN+ activism remains challenging in a complex context characterized by the existence of criminal laws and social stigma, the growing influence of right-wing and conservative actors, and the shrinking democratic spaces. Up to the present, none of the countries in ASEAN have national legislation protecting LGBTQIAN+ persons from discrimination, allowing anti-LGBTQIAN+ groups to run rampant, using child rights framework, protection of freedom of belief and religion, and gender-critical feminism to instill a moral panic and delegitimize LGBTQIAN+ movements.



In this difficult backdrop, the ASEAN SOGIE Caucus (ASC) remains a key player in supporting and enriching local activism to be agile and resilient to the changing landscapes of our region through the following initiatives:

## ASEAN QUEER LEARNING PROGRAM (AQLP)

The ASEAN Queer Learning Program (AQLP) is an online learning program tailored toward developing highly specialized skills for queer activists to undertake interdisciplinary approaches in influencing ASEAN Human Rights institutions. It includes self-paced course modules, synchronous online discussions with experts on human rights, international relations, and civil society, and dedicated mentoring with mentors with whom the participants can connect from time to time. Twenty (20) participants from partner

organizations from Laos, Thailand, Cambodia, Philippines, Malaysia, and Indonesia came to learn together how to better engage in regional human rights advocacy.

## HOLISTIC SECURITY STAFF TRAINING

Following the serious threat we experienced in July 2023 during the preparations for the ASEAN Queer Advocacy Week (AAW), ASC held a Holistic Security Training for its staff in October 2023, to ensure the safety and well-being of our team and those we engage with, and mitigate similar events from happening in the future. ASC remains committed to improving security procedures to enhance the overall safety and security of ASC team, the members, and individuals involved in ASC's mission.

#### **ASEAN CIVIL SOCIETY CONFERENCE/ ASEAN PEOPLE'S FORUM (2023)**

ASC joined forces with ASC member Arus Pelangi and the coalition under Free To Be Me project from Indonesia and the Philippines and brought in 55 Southeast Asian queer human rights defenders to the 2023 ACSC/ APF conference held in September in Jakarta, Indonesia, with the theme, 'Reclaiming safe spaces, restoring democracy in Southeast Asia.'

We were among the 800 participants from a diverse civil society contingent. Prior to the conference, we had one full day of consultation to discuss our emerging issues as well as recommendations to push for at the conference.

In this forum, we advocated for SOGIESC inclusion in the broader civil society movement which can be seen in the conference outcome document. 1

We also aimed toward strengthening regional alternatives and regional solidarity, especially in continuing the discourse around the socio-economic justice that affects the LGBTQIAN+ community in the ASEAN. To this end, ASC co-organized the sessions Beyond Bias: Building Inclusive Economies for a Brighter Future, Dismantling Digital Dictatorship: Safeguarding Rights in the Online Arena, and Feminist Approaches in Alternative Regionalism: Embedding Intersectionality to Advance Gender Equality in ASEAN.

For the first time in this forum, ASC member Arus Pelangi served as one of the co-chairs in the national organizing committee; ASC itself has directly maintained presence and influence as part of the regional program and steering committees as can be seen in the outcome documents. This direct engagement ensured that the LGBTQIAN+ community not only participated but was able to set the tone for the conference, bringing in the queer feminist lens in this intersectional space.

Also for the first time, ACSC/APF 2023 opened with a plenary session featuring an all-women panel of speakers. This session was led and moderated by Lini Zurlia, an Indonesian queer activist and ASC Advocacy Officer.

Throughout 2024, the ASEAN SOGIE Caucus (ASC) has been one of the significant supporters of Nonbinary Thailand with its activism advocating for Non-binary and gender-diverse people in Thailand and Southeast Asia.

I truly hold a positive and appreciative view of ASC thanks to much invaluable experience of being a part of several projects Nonbinary Thailand collaborating with ASC. ASC also supported the first-ever Nonbinary-led march "Nonbinary Rising" on 14th July along with its side event, the first Nonbinary ASEAN Workshop writing "NON-BINARY SEA Rising Manifesto," highlighting our common demands for the Nonbinary community. These events produced fruitful social impacts on the LGBTQIAN+N+ community, and has not just empowered non-binary people in Thailand but also across Southeast Asia. It has given us much delight that ASC has recognized the importance of this document as much as we do and proceeds to further promote our efforts.

I have witnessed how ASC values accessibility of SOGIESC resources by promoting the talented translating and editing team at Nonbinary Thailand to proceed with the translation of the ASEAN QUEER Imagining Volume 2 Thai version. Being involved in producing this translated book empowered the non-binary community in Thailand and gave financial opportunities to our community. Similarly, the ASEAN Queer Learning + also advanced the accessibility of ASEAN and SOGIE education, directly involving the LGBTQIAN+N+ people from Thai and Laos.

I would like to congratulate you on all the success in SOGIESC activism and express my gratitude for how the organization takes importance in the Nonbinary rights advocacy by providing the resources for us Nonbinary activists of SEA region to begin establishing our network drawing a strong path into a hopeful future.

I truly wish for the organization to grow even more in the years to come, being one of the leading forces in expanding the LGBTQIAN+N+ and gender-diverse activism to include greater diverse ranges of people. It would be a great honor for me and everyone at Nonbinary Thailand to continue to be a part of the journey of creating a safe and supportive world for gender-diverse people.





# SOUTH-SOUTH SOLIDARITY

# CREATING SPACES FOR CROSS-MOVEMENT AND INTERSECTIONAL LGBTIQ ADVOCACIES

One of our key wins in 2023 is influencing the Department of Foreign Affairs and Trade (DFAT) of the Government of Australia to allocate a significant amount of resources for support to LGBTQIAN+ movements in Asia and the Pacific. This was a joint call we did together with regional groups, namely APCOM, APTN, Intersex Asia, ILGA Asia. In these meetings, ASC was also able to assert the need for core and flexible funding for LGBTQIAN+ organizations in the region. Such support enables LGBTQIAN+ persons and activists to continue the meaningful work that they do, as well as allows for more space for groups to explore more innovative and inclusive approaches to activism.

To this end, ASC continues to provide platforms for diverse LGBTQIAN+ advocates to connect across movements, strengthening intersectional collaboration in our region through the following programs:

#### **ASEAN QUEER ADVOCACY WEEK (AAW)**

The ASEAN Queer Advocacy Week is a civil society-led initiative to create space for LGBTQIAN+ activists from eleven (11) countries in Southeast Asia to meet, learn about the ASEAN institution, to generate common advocacy agenda, and to have conversations with relevant stakeholders in ASEAN such as the diplomatic community. Previous iterations of this program have been done in Jakarta, Indonesia in 2016, 2018, and 2021 in an online setting amidst travel restrictions due to the COVID-19 pandemic. For 2023, the AAW was co-organized by Arus Pelangi, a local LGBTQIAN+ organization, and FORUM Asia, a regional human rights organization.

Unfortunately, the program had to be canceled in 2023 resulting from severe online threats, and in consideration of the safety of participants and organizers. Days before the start of the AAW, an open call for participants posted on the ASC social media platforms began to go viral as it was picked up by Indonesian conservative influencers and online media news outlets. Soon, a massive online campaign launched, calling to ban the event across social networking sites and online petitions with Change.org, zeroing in on the AAW organizers as targets of online harassment and violence. Offline, local law enforcement conducted surveillance of possible venues of the event and compelled hotel managers to report any similar activity that was going to be held on their premises.

Amidst the backlash and barrage of online attacks, many civil society organizations, both LGBTQIAN+ and non-LGBTQIAN+, stood fiercely in solidarity with the AAW organizers and vehemently condemned these violent crackdowns on LGBTQIAN+ events. FORUM-ASIA along with 36 civil society organizations across Asia <sup>3</sup> released a joint statement condemning the failure of the Indonesian Government to protect the freedom of peaceful assembly by supporting the cancelation of the AAW and urged the government to publicly condemn the systematic attack and stigma against LGBTQIAN+ individuals and organisations.




We are a government of laws, and not of men. As such, it is but right and just that the government should be the frontline in supporting and protecting the welfare of the people.

More importantly, we rally behind the Indonesian LGBT community. We are behind you in this outcry for equality and humane treatment.






You are not alone

PLCC is saddened to learn that AAW 2023, scheduled for this month in Jakarta, Indonesia, has been postponed due to harrassment, hacking, doxing, and threats against the organizers made by local anti-LGBT groups, with complicity from the local police. This emphasizes the need for greater collaboration among regional stakeholders — non-government organizations, business enterprises, and the diplomatic community — to push governments in the region to protect advocates and the LGBTQIA+ community at large in conformity with international human rights law.






#### FORGING INTERSECTIONAL **FEMINIST FUTURES (FIFF)**

ASC has taken a more conscious effort to prioritize well-being. Through the FIFF, the partners initiated the project, "FIFF Community of Care" which has three fundamental steps in achieving its identified goals: (1) development, adoption, translation, and cascading of Guiding Principles of Intersectionality, (2) development of research on intersectional care, and intersectional care needs assessment and database, and (3) generation of greater public awareness on the concept of community care itself, the guiding principles, and the research and the database through an online campaign.

The FIFF community also designed the Intersectional Care Needs Assessment Tool (ICNAT) and has used it to evaluate the situation of thirty-five (35) human rights defenders of sixteen (16) organizations in the FIFF network in the Philippines. The research paper will be available in 2024.



Alternative Development (AltDev), one of our partners from the University of the Philippines Center for Integrative and Development Studies (UP CIDS), helped document and publish the alternative and intersectional practices <sup>4</sup> of our other partners working on the rights of children, LGBTQIAN+ individuals, persons with disabilities, sex workers, persons living with HIV, and migrants.

## COUNTRY-SPECIFIC RESPONSES

ASC remains actively involved in regional advocacy responses in light of challenging circumstances in the region:

#### **INDONESIA**

The KAMI BERANI coalition, which consists of 24 civil society organizations (CSOs) including ASC, drafted a statement <sup>5</sup> on February 2023 expressing regret on the widespread encouragement of discriminatory policies in the form of anti-LGBT regional regulations (Perda) in various regions in Indonesia and demand to stop all forms hatred and intolerance towards minority and vulnerable groups including LGBTQIAN+ as a form of commitment to fulfilling human rights.

On March 21, 2023, the Coalition of Indonesian Civil Society Organizations for UPR <sup>6</sup> issued a joint statement <sup>7</sup> concerning the Indonesian government's

rejection of several recommendations contained in the Universal Periodic Review (UPR) 4th Cycle, pertaining to the respect, protection, and fulfillment of the rights to freedom of opinion, association and peaceful assembly, as well as the right to defend human rights and protect human rights defenders.

#### **MYANMAR**

ASC joined the Milk Tea Alliance Friends of Myanmar, which urged the UN & ASEAN to charge the Myanmar junta accountable for crimes against humanity.

#### **PHILIPPINES**

ASC, together with student councils, LGBTQI+ organizations, and allies for equality, drafted a Unity Statement for Pride Month 2023 to denounce any and all forms of SOGIESC-based discrimination and human rights violations and demand the SOGIE Equality Bill.

#### **OUTSIDE THE REGION**

On Emergency Global Day of Action (25 April 2023), ASC drafted a solidarity statement with LGBTQIAN+ Siblings in Uganda. The statement called on Uganda President Yoweri Museveni to stop Uganda's anti-LGBTQ+ Bill from being legislated into law. This law criminalizes same-sex conduct and subjects LGBT persons in Uganda to life in prison and even the death penalty <sup>8</sup> for "aggravated homosexuality."

# QUEERING ASEAN CIVIL SOCIETY

ASC places a premium on the triumphs gained through cross-movement and solidarity work with broader social justice and democratic movements. As such, we aspire to achieve great strides by prioritizing actions and strategies toward mainstreaming SOGIESC across civil society in ASEAN.



## FEMINIST PARTICIPATORY ACTION RESEARCH (FPAR)

ASEAN SOGIE Caucus, in partnership with Jaringan Transgender Indonesia (JTID), Legal Dignity - Malaysia, GALANG - Philippines, and Arco Iris - Timor Leste, is developing feminist evidence-based advocacy as a tool to undertake regional advocacy work. Feminist evidence-based advocacy uses feminist participatory research (FPAR) as an approach to documenting and producing evidence.

After holding a series of learning sessions in June-October 2022, ASC and partners finally gathered in person in 2023 for the follow-up workshop on Developing Research Agenda facilitated by Lorna Israel and Ryan Sylverio. The research agenda will be used as a baseline for ASC and partners to undertake national research and documentation.

The workshop was also a space to share experiences and learn from each other. There were critiquing sessions in which participants collectively reviewed, enriched, and sharpened each other's agenda and ideas.



The workshop also provided space for Tama and Farah to present their scoping study, "Mapping of the LGBTIQ and SOGIESC-inclusive Studies Using Feminist Participatory Approach in Southeast Asia particularly Indonesia, Malaysia, Timor Leste, the Philippines, Laos, and Cambodia" and get feedback from facilitators and partners. The study itself is currently in the finalization stage.

Some reflections on the workshop:

"As someone who doesn't see myself as a researcher, I think I can do it." – Fir (Malaysia)

"This whole workshop and learning process is a manifestation of the Feminist Participatory Research itself. Our experiences are acknowledged. We learned from and strengthened each other. Furthermore, we even defined the FPAR values that will be carried out in our next steps." – Lini (ASC)

## EXPLORATORY REPORT ON THE INTERSECTION OF SOGIESC

Southeast Asia stands out as a particularly vulnerable region among those most affected by climate change. With a population totaling 640 million, it faces various hazards, including severe weather events and the escalating threat of sea-level rise. Recognizing the intersectionality of climate change impacts and the chronic deterioration of climate conditions, urgent actions must be taken to address these issues. To jumpstart ASC's engagement in this area, it was important to first understand how the issues of climate crises and SOGIESC are interlinked and how LGBTQIAN+ people's lives are impacted by them.


Thus, the conduct of the Exploratory Report On Sexual Orientation, Gender Identity, And Expression And Sex Characteristics (SOGIESC) And Climate Justice In Southeast Asia <sup>9</sup> and the succeeding webinar which aimed to further explore and discuss the complex ways in which climate change and environmental issues disproportionately impact LGBTIQ+ individuals and communities in the ASEAN SEA region. This marks the first of a series of actions toward locating our work in charting a more inclusive and equitable approach to addressing climate change.

# LEVERAGING THE POWER OF ARTS AND CULTURE IN ADVANCING LGBTQIAN+ RIGHTS

ASEAN SOGIE Caucus continues its tradition of artivism, encouraging creative expression as powerful tools for advocacy and social change. Integrating art into activism ensures that the movement remains vibrant, engaging, and impactful, tapping into the rich cultures and imaginings of the ASEAN, and resonating deeply across the region and beyond.



## ASEAN QUEER IMAGININGS (AQI) VOL. 2

ASC published ASEAN Queer Imagining Volume 2. This year's theme is "Queering Sustainable Activism" motivated by the rise of conservatism, shrinking civic spaces, and recovering from the pandemic which significantly impacted queer activism in SEA. This book provides a space for thought leadership for thirteen (13) LGBTQIA+ activists who come from Brunei Darussalam, Cambodia, Indonesia, Laos, Malaysia, Myanmar, and Thailand. This volume showcased more non-binary, trans, and cis-queer women authors and also represented queerblings with intersectional identities such as neurodiverse non-binary people and a former Rohingya refugee. Moreover, the Foreword of the publication was written by Aung Myo Min, the Minister for Human Rights of the National Unity Government of Myanmar.



AQI Vol. 2 was soft-launched in December in Manila, which drew around 50 attendees. Aishia Castellano and Paul Joshua Morante, both AQI contributors based in Manila, were also present to talk about their work.

#### **HEAR QUEER STORIES**

Hear Queer Stories is ASC's podcast platform, dedicated to amplifying and celebrating LGBTIQ narratives from Southeast Asia since 2020. In 2022, ASC collaborated once more with young queer activists from Indonesia to produce four (4) more episodes of the podcast series, this time entitled, "Intersecting Rainbows: Progress, challenges, and solidarity within the queer movements." 10

In the episode, 'Timor-Leste Pride, what's next on the ride?' Laura, a human rights activist from Timor-Leste, talks about the importance of continuing to fight for LGBTIQ+ rights in Timor-Leste, even after the Pride Parade. She unfolds the next steps for the LGBTIQ+ movement in the country and the journey towards a brighter future

Bloom Siriwattakanon, Queer а International Development worker HIV advocate and Non-binary THL founder, talks about their roles with other activists in the episode, 'Breaking Barriers: The Evolution of Thailand's LGBT Political Movement.' He further delves into the challenges faced by the LGBTIQ+ movement in Thailand, as well as the progress that has been achieved.

In the episode, 'Intersecting Rainbows - Lengger Dance: A Symphony of Reconciled Genders', Rianto, an enthusiastic Lengger dancer hailing from Indonesia, describes his captivating journey as a trailblazer in the realm of traditional Indonesian dance.

# ENGAGING WITH REGIONAL AND GLOBAL HR MECHANISMS

ASC also continues to be actively engaged in various regional and global platforms and maintains its involvement in speaking engagements at conferences throughout the year. Here are some of the events we had significant inputs in:

UN WOMEN, with support from the Embassy of Japan, organized a Regional Dialogue on COVID-19 Recovery: Building forward better with women's leadership and participation in March 2023 held in Bangkok, Thailand. In this dialogue, some recommendations were put forward for ASC's future action, such as enhancing the gathering of gender data by looking at the leadership of LGBTQIAN+ in emergency responses, economic contributions of LGBTQIAN+ the pandemic recovery, during contribution of LGBTQIAN+ in care work, as well as continue strengthening digital

platforms for information sharing, learning, and mobilizing.

In the donor pre-conference Resourcing LGBTQ+ Movements For Change organized by Global Philanthropy Project and Equality Australia, ASC Advocacy Officer highlighted the impact of Indonesia's revised criminal code on LGBTQIAN+ organizing.

In a **joint meeting** organized by Women Fund Asia, Dignity Fund, Astrea, and various feminist funders, ASC stressed the need for flexible and institutional funding, as well as support for emergency response.



During the 67th session of the Commission on the Status of Women at the United Nations Headquarters in New York, ASC Advocacy Officer moderated the session on anti-gender movement organized by the LBTQ Caucus at the CSO Forum Parallel Sessions on feminist interventions in digital spaces in Asia led by WFA.

At the Outright International Global Week of Advocacy held at the United Nations Headquarters in New York, ASC was able to have diplomatic engagements with the following missions: the UN LGBTI Core group, Germany, Mexico, Netherlands, the United States, the European Union, Canada, the United Kingdom, and Switzerland, as well as a diplomatic meeting with the Philippines mission.

ASC representatives made presentations during the Civic Innovation Fair 2023, specifically on the intersection of democracy and SOGIESC, and on the situation of LGBTQIA+ rights in Indonesia. This event was organized by Innovation for Change - East Asia in Bangkok, Thailand.

The Human Rights in Asia: Open and Closed Societies in a Post-Pandemic World was held at the Sejong Institute and Global Asia in Seoul, South Korea organized by Sejong Institute. ASC's contribution to this project is the article Advancing Rights for All Persons Regardless of Sexual and Gender Identity. 11

The Asia Democracy Assembly held in Bangkok, Thailand centered around the theme of "Fostering Democracy Movements: Building Strategic Partnerships and Sustainable Cooperation in Asia." ASC designed and facilitated the huddle session on Enabling Inclusive Democracies and Movements, which was attended by 20 participants. Find the outcomes document here.

The 10th Asian Regional Human Rights Defenders Forum in Kuala Lumpur, Malaysia is a regional initiative led by Forum-Asia, Pusat KOMAS, and Suaram. ASC made two presentations during the conference: on the regional component of the work of ASC, and on the workshop on human rights research and documentation.

We participated in the **EU-ASEAN CSO Forum** in Brussels, Belgium ahead of the EU-ASEAN Policy Dialogue on Human Rights (PDHR). The dialogue aimed at fostering partnerships and sharing knowledge and human rights recommendations with the EU and ASEAN representatives to address regional challenges collaboratively. However, a compromised closed-door meeting was held due to objections against Myanmar's military presence and conveyed objections to elected representatives. Despite the challenges posed by political sensitivity, the dialogue enhanced collaboration between EU and ASEAN civil society on human rights, and was able to submit joint recommendations from the forum that were set to influence the PDHR.

The Taiwan-Southeast Civil Society Week organized by the Asia Citizen Future Association (ACFA), produced a report titled, "Exploring Taiwan's Role Amid the Crisis of Shrinking Civic Space in Southeast Asia", where insights and reflections of ASC were documented. ASC's participation in the Taiwan-Southeast Asia Civil Society Week was covered by local Taiwanese media. <sup>12</sup>


